

Charles Bullock *Charles Bullock* - R.S. Hutton

I CHARLES BULLOCK of Fox House Bath Road Eastington Stonehouse in the County of Gloucester HEREBY REVOKE all former Wills and Testamentary dispositions made by me AND DECLARE this to be my last Will which I make this *twenty seventh* day of *February* 1985

1. (a) AS EXECUTORS of this my Will I APPOINT the partners at the date of my death in the firm of WINTERBOTHAM, BALL & GADSDEN of 24 High Street Stonehouse or the firm which at that date has succeeded to and carries on its practice and I express the wish that two and only two of them shall prove my Will

(b) As Trustees of this my Will I APPOINT the persons who take out the first grant of probate (not being a grant limited to settled land) to be obtained in respect of my estate

(c) The expression 'my Trustees' whenever hereinafter used shall mean my Executors and the Trustees or Trustee for the time being whether original or substituted or added

2. (a) I GIVE all my property and assets both real and personal movable and immovable whatsoever and wheresoever not otherwise effectually disposed of by this my Will or any Codicil hereto (including property and assets over which I have a general power of appointment) to my Trustees UPON TRUST to sell call in and convert into money such parts which do not already consist of the same at such time or times and in such manner as they think fit with power to postpone the sale calling in and conversion of the whole or any part or parts thereof for so long as they my Trustees shall in their absolute discretion decide without being liable for loss

(b) MY TRUSTEES shall out of the clear moneys to arise from the said sale calling in and conversion and out of my ready moneys pay

my funeral and testamentary expenses and debts and any legacies given by this my Will or any Codicil hereto

(c) MY TRUSTEES shall stand possessed of the residue of the said moneys and of the property and investments for the time being representing the same and of such part of my said property and assets as shall for the time being remain unsold and unconverted (hereinafter called 'the Trust Fund') upon the trusts and with and subject to the powers and provisions hereinafter declared in this my Will

3. (i) I DIRECT that my Trustees shall hold the Trust Fund and the income thereof for such charitable purposes which may benefit wholly or mainly the inhabitants of Eastington aforesaid as my Trustees may select

(ii) I declare it to be my wish (but without imposing any legal obligation upon my Trustees) that my Trustees shall consider inter alia all or any one or more to the exclusion of the others of the following charities or charitable objects

(a) the provision of playing fields and recreational amenities for the benefit of the inhabitants of Eastington

(b) Eastington Parish Church

(c) Eastington Methodist Church

(d) Old Peoples Welfare

(e) The Guide Dogs for the Blind Association

(f) Muscular Dystrophy Group of Great Britain

(g) Cancer Research Campaign

(iii) In administering this gift my Trustees may exercise all or any of the following powers:

(a) they may themselves pay or apply capital or income for a

charitable purpose

(b) they may pay or apply capital or income to or for the purposes of any charity for the time being in existence

(c) they may by scheme made in writing by them constitute a new trust or body for any charitable purposes and pay or transfer capital or income to such trust or body any such scheme may include any provisions which the Charity Commissioners or the court could lawfully include in a charitable scheme constituted by them and in particular may include provisions for extending the power of investment beyond trustee securities for the holding of investments in the name of a nominee and for the remuneration of any such nominee or of any corporate or professional trustee of such scheme as hereinafter contained

(d) they may constitute as the trustee of any such scheme any person or body corporate whether or not including any of my Trustees themselves

(e) they may instead apply to the Charity Commissioners or the court to constitute a scheme

(f) they may co-operate with or contribute to any other charity having objects substantially similar to the objects of this gift

4. ANY person engaged in any any profession or business shall be entitled to charge and be paid all usual professional or other charges for business transacted time expended and acts done by him or his firm or company or any partner or employee in connection with the administration of my estate and the trusts of this my Will including acts which an executor or trustee not being in any profession or business could or might have done personally (and money payable under the foregoing provision shall not be liable to abatement by reason of

any legacy gift or direction as to priority of payment of legacies contained under this my Will or any Codicil hereto and shall be paid free of all deductions)

5. MY TRUSTEES shall have the following powers which they may exercise at any time and from time to time:

(a) POWER to invest trust moneys in both income producing and non-income producing assets of every kind and to vary investments and in those respects to act in the same full and unrestricted manner as if they themselves were absolutely entitled thereto beneficially

(b) POWER to place or purchase any investment or other asset in the names or name of any persons or person or company as nominees or nominee of then my Trustees

(c) MY TRUSTEES shall not in any circumstances be liable for allowing any investment or other asset to remain for any period however long in the name of a nominee

6. I DESIRE that my body be cremated and that my ashes be placed in a casket and interred at Eastington Parish Church
